

Hostify July 2026 Promotional Offer – Terms & Conditions

Last Updated: July 6, 2026

1. Campaign Overview

The Hostify July 2026 Promotional Offer ("Promotion") is organized and offered by Hostify.

Campaign Period:

*The Promotion is valid from **July 6, 2026, through July 31, 2026, inclusive** ("Campaign Period"), unless withdrawn earlier by Hostify at its sole discretion, subject to applicable law.*

2. Eligibility

*This Promotion is available exclusively to **new Hostify customers**.*

*For the purposes of these Terms, a **New Customer** is a company that:*

- *has never held a paid or trial subscription to the Hostify Property Management System (PMS);*
- *is not an existing Hostify customer;*
- *is not attempting to requalify under a different company name, legal entity, ownership structure, affiliate, subsidiary, or related organization; and*
- *manages **five (5) or more active rental properties** at the time the subscription agreement is signed.*

This Promotion is not available to:

- *existing customers;*
- *resellers;*
- *affiliates;*
- *referral partners receiving separate commercial incentives; or*
- *any customer deemed by Hostify to be circumventing these Terms.*

Hostify reserves the right to verify eligibility before or after the Promotion is applied.

3. Promotional Offer

Eligible customers will receive:

30% off the Hostify PMS subscription fee for the first three (3) consecutive months of a new paid subscription.

The promotional discount:

- *applies only to the base Hostify PMS subscription fee;*
- *does not apply to implementation fees, setup fees, onboarding services, integrations, add-ons, custom development, third-party services, payment processing fees, taxes, or any other charges unless expressly stated otherwise;*
- *begins on the customer's first paid billing cycle following account activation; and*
- *cannot be exchanged for cash, transferred, or applied retroactively.*

After the promotional period ends, the subscription will automatically continue at Hostify's then-current standard pricing unless cancelled in accordance with the applicable subscription agreement.

4. How to Qualify

To receive the Promotion, all of the following conditions must be met:

- *Schedule and attend a Hostify product demo during the Campaign Period.*
- *Execute a subscription agreement with Hostify within **14 calendar days** after attending the demo.*
- *Meet all eligibility requirements described in Section 2.*
- *Activate a new paid Hostify subscription.*

Customers who attend a qualifying demo before the Campaign Period ends may still redeem the Promotion by signing the subscription agreement within the 14-day qualification period, even if the agreement is executed after July 31, 2026.

Attending a demo alone does not reserve promotional pricing or guarantee eligibility.

5. Restrictions

Unless otherwise agreed in writing by Hostify:

- *this Promotion cannot be combined with any other discount, promotion, referral reward, affiliate incentive, reseller pricing, partner agreement, or special commercial arrangement;*

- *the Promotion is limited to one promotional subscription per eligible customer;*
 - *promotional pricing has no cash value;*
 - *promotional benefits may not be sold, assigned, transferred, or substituted.*

6. Billing, Pricing & Taxes

All prices are exclusive of applicable taxes (including VAT, GST, sales tax, or similar taxes) unless expressly stated otherwise.

Applicable taxes will be added where required by law based on the customer's billing address and jurisdiction.

Payment terms, billing cycles, currencies, renewal conditions, and cancellation policies are governed by Hostify's standard Terms of Service.

If a promotional discount is omitted from an invoice due to an administrative error, Hostify may, at its sole discretion, issue a corrected invoice or account credit.

7. Changes, Cancellation & Fraud

Hostify reserves the right to:

- *verify eligibility at any time;*
- *reject applications that do not satisfy these Terms;*
- *withdraw promotional benefits where fraud, abuse, misrepresentation, or circumvention is reasonably suspected; and*
- *suspend, modify, extend, or terminate the Promotion where permitted by applicable law.*

Any changes to these Terms will not retroactively remove promotional benefits already granted to eligible customers unless required by law or where fraud or misuse is involved.

Hostify may terminate promotional benefits if a customer is found to have provided false or misleading information during the qualification process.

8. Privacy & Data Protection

Personal information collected in connection with this Promotion—including names, email addresses, company details, billing information, and other relevant business information—will

be processed in accordance with Hostify's Privacy Policy and applicable data protection laws, including the EU General Data Protection Regulation (GDPR), the UK GDPR where applicable, and other relevant privacy legislation.

By participating in this Promotion, customers agree that Hostify may contact them regarding:

- *their demo request;*
- *subscription setup;*
- *onboarding;*
- *account administration; and*
- *this Promotion.*

Customers may opt out of marketing communications at any time without affecting essential service-related communications.

9. Limitation of Liability

To the fullest extent permitted by applicable law, Hostify shall not be liable for any indirect, incidental, consequential, special, or punitive damages arising from participation in this Promotion or the use of promotional pricing.

Nothing in these Terms limits or excludes liability that cannot legally be limited or excluded, including liability for fraud, fraudulent misrepresentation, death, or personal injury caused by negligence where required by applicable law.

Hostify shall not be responsible for delays or failures resulting from circumstances beyond its reasonable control, including natural disasters, internet outages, government actions, labor disputes, cyberattacks, or other force majeure events.

10. Governing Law

These Terms are governed by the laws of the State of Delaware, United States, without regard to its conflict-of-law principles.

Any dispute arising out of or relating to this Promotion shall be subject to the exclusive jurisdiction of the state or federal courts located in Delaware, USA.

If mandatory consumer protection or data protection laws in the customer's jurisdiction provide rights that cannot legally be waived, nothing in these Terms limits those statutory rights.

11. Relationship with Other Agreements

These promotional Terms supplement Hostify's standard Terms of Service.

In the event of any conflict between these Terms and the Hostify Subscription Agreement or Terms of Service, the Subscription Agreement and Terms of Service shall prevail unless these promotional Terms expressly provide otherwise.

12. Severability

If any provision of these Terms is held to be invalid, illegal, or unenforceable, the remaining provisions shall remain in full force and effect.
